**Membership:** Each water user must be a member. A non-refundable membership fee must be paid by the applicant

**Deposit:** The customer must pay a deposit which will be held in escrow. Customers will be able to transfer their deposit for a fee to a different location on the system if necessary. The deposit will be refunded upon termination of service provided no indebtedness is pending. Billing can run a month or more behind.

**Service Connection Charge:** A minimum service connection charge must be paid by the applicant prior to the installation of new service. The service box will be placed at the applicant's property line in the easement of the road. The applicant must install the line from the box to the residence at no additional cost to the water system.


 **A residential 3/4"- 5/8" meter or a 3/4" line is not adequate for a sprinkler system.** 


**Sprinkler Systems & Cross Connection Control:** Each member is responsible for adequate plumbing and Cross Connection Control within their premises. A Pressure Vacuum Breaker (PVB) above Ground Backflow Preventer Assembly or a Double Check above Ground Backflow Preventer Assembly is required for a sprinkler system on Auburn Water System. A Reduced Pressure Principle above Ground Backflow Preventer Assembly is required for commercial services, properties with auxiliary water supplies, and Chemically injected Sprinkler Systems, etc. Above Ground Backflow Preventer Assemblies must be tested annually. There is a charge for this test. Auburn Water System reserves the right to inspect all new installations, any questionable situations, and a systematic surveillance of all existing installations. A copy of Auburn Water System Cross Connection Control Program Rules and Regulations is available upon request.

**Other Charges:** A connection fee is charged any time the water meter is either turned on or read at an existing meter. This includes reconnection for non-payment or temporary disconnection. There is a published Fee schedule for all returned checks.

**Attorney's Fees:** The prevailing party shall have the right to collect from the other party reasonable cost and attorney's fees incurred in enforcing this Agreement including any collection action.

**City Of Crestview Sewer/Trash Service Area:**

 *Customers who reside in the City of Crestview Sewer & Trash Service area must make application with the City of Crestview. Auburn Water System, Inc. will not turn on the water service until we have received confirmation of application from the City of Crestview.*

 *I further understand that Auburn Water has the right to disconnect my water for non-payment of water, sewer service, and/or trash service charges. A reconnect fee will apply.*
